I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself, including but not limited to personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my or my child(ren)'s association with The Actors Room, attendance at The Actors Room facilities, or participation in The Actors Room programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless The Actors Room, its employees, agents, representatives, contractors, affiliates, and all other connected parties of and from any Claims, including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating thereto.
